Your passport picture: stand up against a white wall. Have light either directly above you or shooting at you from both sides to avoid shadows. If you can do all three, that's ideal. (You can use your phone to take the pic.) In a photo editor, crop the picture to a 2" x 2" size. You will also need a copy of the picture to measure 600 pixel wide by 900 pixel high to upload into the LRO. (You can also go and have a passport photo taken, check out CVS, Walgreens, Rite Aid, FedEx, or UPS to see if one in your area takes passport photos. If so, get three.)

You can type in your witness's info, if you know it, except for the date line and signature line. They must do those in front of the notary. Type or Write in the State where the Witness lives in the Notary Section. If you leave this to the Notary to write in, make sure they do not write 'State of' which is the sea jurisdiction, you want just the state name for land and soil jurisdiction. You want 'name County' not 'County of name.' Watch jurisdiction.
