U.S. Citizen vs. American State National

- U.S Citizens **cannot own** physical land. They are tenants not landlords.
- In all cases where U.S. Citizens live in homes, they only have **tenant** rights, even if their Mortgages are paid off.
- If Property Taxes (**rent forever**) are not paid, people can lose their property.
- Once a man or woman declares their proper American status on the Public Record **everything changes**.
- American State Nationals (ASNs) are **exempt** from Federal Income Taxes.
- ASNs can obtain allodial (true ownership) **property titles**.
- ASNs do not live in Washington D.C. and they are not Federal employees.

The American Civil Peace Flag

The American Civil Peace Flag was first flown in 1767 when the "Sons of Liberty" rebelled against the Stamp Act.



They hung a British East India Company flag sideways and flew it from the "Liberty Tree". The **vertical stripes** signify people's independence and sovereignty from the Crown.
