

Infiltrator Report to the Federation of States, date: 12/18/2023

To: The Federation of States

From: The Michigan Assembly Coordinator

It is with a heavy heart I must recognize the following recent events and attacks on The Michigan Assembly.

Leonard Lee, Dec 2022 – Oct 2023 (infiltration attempt from outside):

First, a word about Leonard Lee (LL). In learning from the Florida coordinator, I probably should have reported suspicious activity on LL's part earlier, but I normally err on the side of seeing how things play out. I don't believe it's my job to chase trolls; rather, set up The Michigan Assembly (TMA). LL was apparently triggered by a rather sophisticated mailing we did of a welcome packet we'd developed, which we sent to existing ASNs first because we didn't have it when they were new. LL had contempt for it, criticized us for it, which is his opinion, but I thought unnecessary.

We'd been in contact with LL from December 2022 and invited him to what we call our vetting process (internal terms, meaning verification of who and getting to know; currently adjusting our terminology to conform to relevant AVR articles and sent msg to her about it). LL responded to the call February 2023 to engage; he didn't respond until April with a request to get on Mattermost (MM). He sent the initial contact card and Getting to Know You form the first part of September 2023 and wanted to know if that would get him into MM. Currently, and since we'd had troublemakers enter MM before even being interviewed, we put in our Roadmap/Operations Plan (hereinafter "Roadmap" which was approved by the Federation) that people would be invited to MM upon becoming members of our GA, which includes an autographed/sealed ASN Agreement to the Roadmap and an autographed/sealed Affirmation of Purpose and Conduct.

LL somehow was invited to MM without our consent on Michigan, meaning we didn't invite him. And as these things were being discussed at the international Federation level (because people like Josh Pelltier on Georgia and Cynthia Pinkston on North Carolina were causing trouble waging war with other ASNs on MM), LL was being added to most of the channels I was frequenting on MM including my own. I tried following up with him to correct this apparent error and he scheduled an entry interview on September 28th, 2023; he never showed.

Shortly thereafter, LL began stirring up trouble on TMA Telegram channel against the pinned rules of conduct there and contacting individual GA members through that group to cause dissention among the assembly, targeting GA members with unsolicited texts designed to attack the Coordinator; lies, false accusations, doubt casting and posturing, etc. Due to these events, on October 7th, the Coordinator sent him results of his evaluation at Step 2 (Entry Interview) and said he wouldn't be considered for GA until he met 6 tasks for him to complete, like the Universal Self-Governance Training, the reading of certain AVR articles, SIA Course, attending TMA Study Group classes, etc. Instead of doing any of that to enrich himself, he showed up on the **new** YT channel run by Niti Bali with Cynthia Pinkston to bash Michigan and the Coordinator with misrepresentations and false accusations. I let it play out; joining the fray takes time away from the assembly and doesn't help the conversation in email or text.

Meantime, some of our public officials and members let me know LL had been contacting them separately to sow dissention, and LL even met with Troy Brown and Kristine Casey at Troy's domicile and talked for about 3 hours during the month of October. They reported that he was unwilling to change, he'd accused Anna's son of treason to them verbally, he said he didn't really want to join the assembly (just attend our meetings though he'd never showed to any public meeting; he wanted to come to closed sessions), and that he was a DOT driver by trade, making him a dual citizen and not eligible to be a GA member here anyway (such is the level of security we are executing here, also in the

Roadmap). Further, he admitted to being taught in study groups by Cynthia Pinkston on North Carolina (who has no jurisdiction to instruct our people; she should have told him to come to Michigan Study Groups).

I believe LL to be an operative, either paid, sent by North Carolina, or of his own making due to his personality, and he had been attempting infiltration. Since he couldn't infiltrate Michigan, the operation turned into infiltrating the minds of the Federation and public via the Niti Bali YT channel, and the loaded lines of questioning and public pressure being brought to bear on Anna, while her husband was in the hospital, was indeed dishonorable; and they used those presumptions and her attempts to smooth over and answer to twist words and misrepresent and further falsely accuse Michigan and other states. LL is and has been trained to be a verbal **bomb thrower** in order to cause chaos and doubt in his victims, particularly to disrupt organized behavior.

Since then, TMA members have shown some doubts and concerns that they did not before, so LL definitely did some damage to the psyche of our GA members here. I decided to call a self-imposed time-out for 90 days in mid-November for structured training on steps we missed, after a public officials' workshop we attended in person for a couple of days, and as recommended by my 1st Co-coordinator. At the least LL had shown us that our members weren't as solid as we thought they were in their knowledge and training, and we discovered we missed a step in our organizational plans: We had no Orientation Plan, and that is now being fixed during this time-out training period.

Nicholas Kiciak, June 2023 – Present (infiltration from within):

Nicholas Kiciak (NK) came to us via our TMA Public meetings on zoom (Events tab, TheMichiganAssembly.org). He and his brother, Anthony Foxx, were coming to us from an incorporated "patriot" organization here called "We the Counties" which preaches bottom-up government from the county level up. Now, I informed them that AVR has published many articles detailing the importance of the state assemblies assembling first, and then getting the county assemblies in order and training everyone how the American system works, getting all the pieces in place before declaring the assemblies as autonomous American government. In fact, Anna has been very clear that during the assembling phase we are under Federation oversight via the Summoning Authority, and that the delegated authority/jurisdiction given to the Coordinator by the Federation is to ensure that the assemblies are set up correctly, to wit, "During the assembling phase, and until the Assembly is fully functional and on its own, the Coordinator is in charge of making sure that the Assembly members are properly declared and recorded as Americans, and that the four functions that are common to all American Assemblies are up and going. Once the Assembly is organized and fully functional with these basics in place, the Coordinator's position sunsets." That is what we have detailed in our Roadmap, and that's what we are executing, which is shown to every member before joining; that it is the service they are agreeing to with the ASN agreement. I also informed them that "We the Counties" is a corporation in the incorporated governance system as a subsidiary and that's why they won't make any headway railing against the corporation that chartered them, nor against any of their subsidiaries. They seemed to respond to that and came our way, joining the main TMA Telegram channel.

NK insisted on trying to teach the Coordinator the **trust law** teachings of TJ Henderson, even inviting me to a seminar he was conducting via an organization called "Americans in Action", and further inviting me to something called "Class for Motion to Dismiss for lack of Subject Matter Jurisdiction"... operations training on addressing foreign courts, which we don't do; and I informed him of such. That was over June and July 2023. During August, I had been sending him AVR articles to address some of what he was espousing; I am also in the habit of posting what articles I'm reading in the TMA Telegram channel, so he's been exposed to at least those as we go.

By August 16th, NK had submitted ASN paperwork to our lead RS and got on the land and soil jurisdiction; however, time would prove out that he never did a voter revocation, nor a military severance letter, which we discovered on December 14th, 2023 ; therefore, he is still a dual citizen; both

as a MUNICIPAL citizen of the United States and as a British Territorial U.S. Citizen (service with the Marines, no less, who are clearly under admiralty law); and he never declared himself as such from any reading of the Bivens decision, so he's already discredited for failure to disclose. We gave him a week to get it done and on the public record.

During the months of July and August, as Coordinator much of my time was being taken up by attacks from the local MUNICIPAL District Court (89th) for which I was on my own crash course on how to defend myself... not in their courts, but with ASN remedies. In summary, and as previously reported to TASA (see 20230917 Intel Report on Chev Cty Jailing.pdf, posted in various channels on MM, including the Coordinator channel from which Teri Sahm got a copy; attached). During this time, much was put on hold and it also showed us where our weaknesses were and what redundancies needed to be put into place, which I began working on by appointing more Co-coordinators (we have 3 now) and delegating more responsibilities to them. Every task should not revolve around the Coordinator and overwork him/her; we now have a better succession plan of Co-coordinators within the Coordinator jurisdiction for the assembling phase. That means the entry interviews didn't happen while I was working on the administrative process and when kidnapped.

During September-October 2023 we got some of that done and Anthony Foxx and NK were brought on board with my apologies for the delay. However, due to all the corporate court drama and stress, a paperwork review was overlooked, and that's the part wherein we (coordinators, vetting committee, and recording secretaries) must take responsibility for missing NK's lack of notice letters, including the voter revocation and military severance. On October 26th, 2023, I sent him the Roadmap, ASN Agreement, and Affirmation of Purpose and Conduct; we also conducted his entry interview wherein he gave some interesting answers and comments. He'd said that he was attracted to us because we were teaching deprogramming and reprogramming (we say unlearn and relearn). He'd given the answer of **compromise** on the question of how to resolve conflict (the choices were *compromise* or *rational persuasion*). He'd agreed that leadership in an assembly should be about educating others with what they don't know and that an assemblyman should respect another sovereign's responsibilities without interference (paraphrase). By the end of the interview, he wanted to discuss further his answer on conflict resolution. In the discussion he did not choose **rational persuasion** because, in his view, people can use logic to manipulate others (which I believe shows how he thinks). I informed him that I disagreed with that; however, I educated him that once someone seeks to manipulate, that someone is no longer being rational as manipulation is a trait of psychopathy. He thanked me for that explanation, which he admitted he hadn't thought of. On October 30th, 2023, I received his autographed and sealed agreement and Affirmation back and added it to his assembly record.

During November and the first half of December, we noticed that NK was gathering more and more email addresses on assembly members. He'd begun doing email blasts to any GA member he could add to any message he was sending to the Coordinator, whether it was GA business or not. In fact, I began to realize that he was attempting to educate people in the public TMA Telegram channel and in emails his corporate indoctrination that he was apparently refusing to unlearn. NK seems to operate in the realm of cordiality, yet inferring or insinuating either insult, doubt, and disinformation (i.e., corporate information he wants to teach others). He cannot seem to speak without using big words, psychological theories, "laws of" this or that without revealing his source of authority for it (and sometimes it's himself); all signs of either dazzling people with brilliance or baffling them with b.s. And I think it is more the latter with the appearance of the former.

By December 1st NK was asking for ASN contact lists under the guise of outreach (to those who have specifically wanted to be left in the private and for whom the RS's make contact as their clients) when the Outreach Committee Chair is completely capable of requesting that herself. Instead of learning what we were teaching him in the now GA training meetings, he wanted to be the newbie (who doesn't really know anything about the real American system, see The Rude Awakening, Article 3367) to "teach" everyone else what they should be learning, and also to begin challenging the

Coordinator's jurisdiction, judging the assembly, demanding explanations like we're doing something wrong... all with the comprehension of an indoctrinated dual citizen. These are the hallmarks of an infiltrator. Via emails, open calls, and texts to other members, he has done the following (evidence on file):

From Article 3374...

- 1. Attacked the Coordinator
- 2. Attacked the foundational elements: The Assembling Process
- 3. Attack progress made so far.
- 5. Attempt to Divide and Conquer.
- 6. Gossip and cast doubts.
- 7. Accuse others of what he's doing himself.
- 9. Private agendas.
- 10. Attempts to hijack meeting agendas (particularly education training with his own disinformation directly contradicting the Coordinator's presentation).
- 11. Lead with ego.
- 12. Attempts to elect himself into several different offices; offers to "help" anyone without being asked and imposing himself on committee functions without appointment.
- 13. Create conflict; refuse to work cooperatively.
- 15. Avoid oversight of his activities; complain about Coordinator role.
- 17. Talk about states' rights, but don't talk about states' responsibilities.
- 20. Ooze disapproval and superiority, et al.
- 21. He's preachy and drags his philosophical belief system into everything, even the beliefs of the "ancients" with non-specificity.
- 22. Advocate forms of insurrection against the lawful government – currently attempting to file complaints/charges with the Federation for treason on the Coordinator, attempting in my view to force the same situation as Missouri (which the Coordinator and GA there was responsible for) to trick the Federation into thinking they need to dissolve Michigan. No one is with him on that; there is nothing officially afoot like the Missouri situation on Michigan.
- 23. Hyper-critical and "down on everything" advancing the establishment of our Orientation Plan under the guise of establishing assembly structures, which he doesn't know how to do (hence the need for the Orientation Plan as no one is ready for JA yet, for example).
- 24. He's an attention seeker, always making everything about him and his concerns/questions (difference between questions and constant challenging).

"We want to bring home as many Americans as we can, but we don't have to put up with foreign agendas, obstruction, or interference." And as such, we are implementing our disciplinary process in our Roadmap.

Violations of TMA Roadmap, Standard of Conduct...

- D.1) Adherence to Creator's Moral Law.
- D.2) There are to be no politics brought from the corporate sea jurisdiction onto the land jurisdiction.
- D.3) There are to be no internal factions, such as enforced personalities or internal relationships that take precedence one over another outside of the proper context of the assembly phase according to lines of responsibilities.
- D.5) Members of The Michigan Assembly are to maintain their honor, integrity (keep their word), civility, and trustworthiness by continually earning other Assembly member's trust and never betraying it. Personal attacks of any kind will not be tolerated. Lying will not be tolerated.

Gossip will not be tolerated. Any discussions dealing with others about behaviors and events must be done with objectivity.

- D.6) Members will conduct themselves with objectivity of perspective and speech (his speech is biased in favor of his indoctrination with an attitude of superiority and “objective reality” presumption).
- D.7) Intolerable behaviors:
 - Personal attacks (particularly on the Coordinator, false accusations).
 - Lying (by misrepresentation and not keeping his word).
 - Lack of transparency (while falsely accusing Coordinator of same).
 - Controlling/withholding information (while falsely accusing Coordinator of same; he only discusses biased points that benefit his ego or how he looks/seems to others).
 - Discussing or releasing Assembly business/information on public channels.
 - Pushing politics or politicking/posturing with assembly members; seeking to do the same with other ASNs.

Violations of TMA Affirmation of Purpose and Conduct:

- Para.1) “...nor act as an insurrectionist...”, which I believe he is doing trying to drum up “treason” charges against the Coordinator.
- Para.2) “...I will conduct myself with honor, respect, peace and love as I self-govern... I will leave my ego at the door,....”
- Para.4) I affirm that I understand the process of Assembling, the plan for reconstructing our lawful government, and my role as an assembly member, as well as the role of the Federation, The United States of America unincorporated, and the Coordinator as Federation representative implementing the assembling process.
- Para.5) I affirm that I am here to support the Assembly.... I will not force my will on any member of the Assembly, nor on the Assembly as a Committee of the Whole. I will not gossip, spread rumors, tell lies, hold secret meetings, or engage in any activity to destroy the good work that has been diligently and lovingly accomplished....
- Para.6) I affirm that I will stay in my lane, and will continue to study to educate and inform myself, so that I am able to turn to others to educate and inform. I will refer to myself as an American on the Land & Soil Jurisdiction. I am either an American State National or American State Citizen. [Which as a dual citizen, he is not in terms of standing with the GA. He hasn’t stayed in his lane, learned what we teach, shown any evidence of studying to educate and inform himself in real American government or land jurisdiction, yet wants to educate and inform others with his indoctrination, which he was neither tasked or asked to do, so getting out of his lane to trespass upon Coordinator jurisdiction.]
- Para.7) I affirm that I am aware that The Michigan Assembly consists of willing and able volunteers.... [NK’s posturing insinuates and seems to demand the attention and accountability of people who are paid fulltime employees, not volunteer sovereigns.]
- Para.9) I affirm that I will not lie to The Michigan Assembly or the Federation of States, nor misrepresent any information, people, or mission/goal of or to the same.

Nicholas Kiciak was given all this information before he signed agreement to it as an ASN and made his Affirmation. And now, in true U.S. Citizen fashion, he’s dishonored himself by breaking his word and is in breach of contract. At this point he has broken so many of the provisions in the Roadmap Standard of Conduct during the first 2 weeks that he’s blown through all step-by-step chances, and even after an intervention Coordinator call on December 14th, 2023 to try to reach him with course correction, he has continued to ramp up attempts at division, accusations, trespass on the Coordinator jurisdiction, and the like, including now dangerous false accusations that we will certainly

not tolerate one bit. Therefore, he will be censured on the record and dismissed from the Assembly for cause in accordance with TMA Roadmap Standard of Conduct.
