Infiltrator Report to the Federation of States, date: 01/31/2024

To: The Federation of States From: The Michigan Assembly Coordinator

It is with a heavy heart I must recognize the following recent events and attacks on The Michigan Assembly, yet again.

**Kimberly Mayer Watling**, December 2023 – January 18, 2024 (infiltration from within): This is the Notice I sent to Kimberly Mayer Watling and the GA about her withdrawal/dismissal from TMA GA:

The Censure and Dismissal from GA of Kimberly Watling

I'm sorry you did not come to the TMA Coordinator call today to explain your actions. However, I see that you have already sent your withdrawal email from the assembly. I am rebutting your further presumption that you have any right to claim a place at the table as a TMA member during this assembling phase of our reconstruction. This is now how it works on Michigan, and your presumptions that social media operating from other states or under false pretenses and misrepresentations is in any way binding on our sovereign state. What you don't know is that all of our documentation was not only requested by the Federation to gain reinstatement as an assembly, but is also done under common law as a pledge of sovereigns following full disclosure of what we're building, how and why, which you indeed agreed to, but have violated your agreement and your honor.

By your own volunteerism and withdrawal of your agreement to the TMA Roadmap, you are now an ASN in the private. Further, due to the following things we have against you in your behaviors that are in violation of the TMA Roadmap, you are barred from being a TMA member in the future, so please do not attempt to come to our meeting and cause trouble.

In particular, the following challenges/attacks on the Coordinator jurisdiction and other intolerable offenses occured:

1. Electing yourself to point of contact to coordinate a TMA class of ppl to attend a class with the claim of helping set up our militia pillar... from unknown content by U.S. Citizens. This is was done and presented to the GA by presumption.

2. Making the decision for TMA that such an event should be coordinated in the name of the assembly and pushing for it as if she'd been tasked by the Coordinator to do it (which you were not). No decision was ever made, neither was any such appointment.

3. During a time of GA time-out for training purposes, you attempted to mislead the GA into thinking that this was part of our orientation training, again by unsaid presumption, which is an attempt to set the agenda for a major education effort being put together under the direction of the Coordinator (who does set the agenda) via the Education Committee and the Coordinator Group. This is the behavior of controlled opposition and against the stated interests of TMA at this time. We are in time-out, not making GA decisions, nor setting up new pillars. [We are shoring up our foundation via Orientation Plan establishment and teaching, which was pointed

out during the process of Orientation Plan development and classes. [We are in a self-imposed timeout to shore up our foundations by establishing our Orientation Plan, which was missing, before setting up new pillars. This was pointed out in our training calls.]

4. You used TMA assets (MM, the Recorder Group, TMA Public Call) to promote a 3rd party's sales (from U.S. Citizens) with the above presumptions in TMA's name without jurisdiction, permission, or appointment, and then asking for email blasts to ASN Lists requiring they respond to you in order to build an email list of private ASNs, which would be misused by you as detailed below, meaning it was the purpose of the scheme in the first place, or likely very probable since you and Nicholas Kiciak had tried to get such an email list from us during December. [Instead, we protected the private information of our people.]

5. You controlled information with you presumptions and email dealings, making plans behind the scenes to subvert the plans of the assembly (which can be construed to be secret meetings). 6. You discussed supposed TMA business on an open public call on Jan 4th promoting this milita class, presenting it as a group rate class being put together by TMA without jurisdiction or appointment to do so. Even though TMA has indeed taken that effort away from you to offer to the GA members only as an extracurricular activity to vet the information being presented, it is not any part of setting our militia pillar at this time, nor is it an official TMA business. Presenting it as such in an open public call with an open invitation in a forum TMA owns violates its purpose and the presumption that it was TMA business with an open invitation to the public is a violation of TMA Standards of Conduct (D.7.f).

7. Attempts at creating internal factions via email blasts to GA members, using their private email addresses in general distribution for all to see without any of their consent, for which we have received complaints. We have evidence that you are also working with Nicholas Kiciak, a known infiltrator and provocateur.

8. There is strong indications that you have lied repeatedly to the Coordinator if not the GA (f.g., claiming to be the POC for an event TMA was not sponsoring is a lie); more specifically, claiming that you have a problem using her email, that it doesn't work to the Coordinator; meanwhile, setting up a Point of Contact scheme for an event in TMA's name, which is not the behavior of someone who's email doesn't work. Neither are email blasts to GA members, including Nicholas Kiciak, but excluding the Coordinator for said email chains.

9. Using GA member private information on email blasts visible to all without consent of those sovereigns you are involving in your personal business, i.e., claiming that you can't get your background check you ordered from the ASN Store (even though you no longer have a position to require it since you resigned as Outreach Committee Chair [on or about 12/19/2023]), instead of self-governing, trying to involve ppl who arent' involved, and including distribution to a known provocateur operative on another state, Cynthia Pinkston, which is an international trespass against those sovereigns included in the CC field. Essentially, you gave their personal private contact information to a known international operative who is trying to sow chaos and division at the federation level between the states [which is a warring act and will be further reported to the PKTF for investigation].

10. You have repeatedly shown a pushing of your politics on others during public and GA meetings (even with a soft hand), which is not allowed under TMA Standards of Conduct (D.2);

this was further solidified by studying your emails carefully in that you believe that there are no bad people and everyone deserves to be involved with everything we do, whether they're involved or not, booted out of TMA as a provocateur or not, and then imposing this on TMA with your behavior while violating your agreement and the rights of other sovereigns. This was most recently overtly defended in an email chain to Dee Overly. Even though you have taken the self-governance classes, you have apparently not learned anything as your behavior has gotten worse, not better.

End of Notice.

Offenses by Kimberly Watling to support she as infiltrator:

From Article 3374...

- 1. Attacked the Coordinator (or the Coordinator jurisdiction)
- 2. Attacked the foundational elements: The Assembling Process via TMA Roadmap.
- 3. Attack progress made so far via misdirection of TMA members from mission/goals of agenda, while appearing to "help".
- 5. Attempt to Divide and Conquer.
- 6. Gossip and cast doubts.
- 7. Accuse others of what she's doing herself.
- 9. Private agendas.
- 10. Attempts to hijack meeting agendas (particularly a public call with a misdirection to an agenda TMA had not been pursuing yet).
- 11. Lead with ego.
- 12. Attempts to elect himself into several different offices; acting as Outreach Chair when she'd already resigned and as point of contact for an effort as personal agenda in TMA's name.
- 13. Create conflict; refuse to work cooperatively.

"We want to bring home as many Americans as we can, but we don't have to put up with foreign agendas, obstruction, or interference." And as such, we are implementing our disciplinary process in our Roadmap.

Violations of TMA Roadmap, Standard of Conduct...

- D.1) Adherence to Creator's Moral Law.
- D.2) There are to be no politics brought from the corporate sea jurisdiction onto the land jurisdiction.
- D.3) There are to be no internal factions, such as enforced personalities or internal relationships that take precedence one over another outside of the proper context of the assembly phase according to lines of responsibilities.
- D.5) Members of The Michigan Assembly are to maintain their honor, integrity (keep their word), civility, and trustworthiness by continually earning other Assembly member's trust and never betraying it. Personal attacks of any kind will not be tolerated. Lying will not be tolerated.

Gossip will not be tolerated. Any discussions dealing with others about behaviors and events must be done with objectivity.

- D.6) Members will conduct themselves with objectivity of perspective and speech (her speech is integrated with her personal biases, enforcing her beliefs on others with overly flowery/sugary speech that is used to manipulate others).
- D.7) Intolerable behaviors:
  - Personal attacks (particularly on the Coordinator's jurisdiction).
  - Lying (by misrepresentation and not keeping her word).
  - Lack of transparency (implementing an op to obtain private ASN contact information without informing or asking the Coordinator; email chains without a CC to the Coordinator about official business relating to her background check while informing infiltrator Nicholas Kiciak instead).
  - Controlling/withholding information.
  - Discussing or releasing Assembly business/information on public channels.
  - Pushing politics or politicking/posturing with assembly members; seeking to do the same with other ASNs.

Violations of TMA Affirmation of Purpose and Conduct:

- Para.1) "....nor act as an insurrectionist....", based on her email chains, she is working with infiltrator and possible insurrectionist Nicholas Kiciak.
- Para.2) "....I will conduct myself with honor, respect, peace and love as I self-govern... I will leave my ego at the door,...." while attempting to inflict her will on others without jurisdiction.
- Para.4) I affirm that I understand the process of Assembling, the plan for reconstructing our lawful government, and my role as an assembly member, as well as the role of the Federation, The United States of America unincorporated, and the Coordinator as Federation representative implementing the assembling process.
- Para.5) I affirm that I am here to support the Assembly.... I will not force my will on any member of the Assembly, nor on the Assembly as a Committee of the Whole. I will not gossip, spread rumors, tell lies, hold secret meetings, or engage in any activity to destroy the good work that has been diligently and lovingly accomplished....
- Para.6) I affirm that I will stay in my lane, and will continue to study to educate and inform myself, so that I am able to turn to others to educate and inform. I will refer to myself as an American on the Land & Soil Jurisdiction. I am either an American State National or American State Citizen. [Kimberly Watling has demonstrated on several occasions that she doesn't even comprehend the difference between a U.S. Citizen and an ASC as just one example of this disconnect.]
- Para.7) I affirm that I am aware that The Michigan Assembly consists of willing and able volunteers.... [Kimberly Watling's unwillingness to do her job on what she has volunteered for, not keeping her word in her volunteerism, and yet getting busy to accomplish personal agendas with Nicholas Kiciak behind the scenes shows differently.]
- Para.9) I affirm that I will not lie to The Michigan Assembly or the Federation of States, nor misrepresent any information, people, or mission/goal of or to the same.

Kimberly Watling was given all this information before she signed agreement to it as an ASN and made his Affirmation. And now, in true U.S. Citizen fashion, she's dishonored himself by breaking his word and is in breach of contract; however, she has withdrawn her TMA ASN Agreement, and therefore, withdrawn from The Michigan Assembly.

UPDATE: As of January 30<sup>th</sup>, 2024, it has come to light that Kimberly Watling continues to network with Nicholas Kiciak and others to subvert and operate against The Michigan Assembly via email, contacting any ASN on Michigan or GA member they can get contact information on, using it unlawfully and without consent by those people, in order to create fear, dissent, division, chaos, doubt, mistrust, and to spread lies about TMA and the Coordinator and other public officials of TMA. First it was an operation to try and obtain as much private ASN/GA member information as possible; and now a psyop to try and divide and conquor. Kimberly has lended her flowery/sugary speech to Nicholas Kiciak as he continues to spread disinformation and misrepresentation on social media, like Telegram, and via emails blasts.
