It is with a heavy heart I must recognize the following recent events and attacks on The Michigan Assembly, yet again.

Richard Glen Worden, December 7, 2023 - January 15, 2024 (infiltration from within):

This is the Notice I sent to Richard Glen Worden and the GA about his withdrawal from TMA GA with a response to a letter I received from him on January 18th, 2024:

In reviewing your physical letter, there are several things I wish to summarize to introduce my response to you in order to save time and space. I have said in the past there are more important things for TMA to do than wrangle on about dissention in the ranks caused by others who turned out to be infiltrators or agitators (for whatever their reasons may be), which has caused doubt in some that do not seem to be solid in themselves, what they're supposed to know about the assembling process, their self-education, and even their own confidence in their own evaluation of full disclosures and agreements. I do not give away my time cavalierly, and no one has the right to demand my time from me as a volunteer. Therefore, I will address the highlights of your letter in summary.

Your letter is riddled with many false accusations, starting with me ignoring your communications with me. Frankly, when you sent me a physical letter, I was in the process of answering your other communicate you referenced. For a man who is retired, it sounds like you have a lot of time on your hands; however, I do not. I have many things demanding time in my private life, so I need to prioritize; it's just that simple. To attack that is to think you have the right to infringe on my sovereignty to manage my own life and affairs or responsibilities. Instead, the reality is, you walked away from us and did not make good on your agreement you put your autograph and seal to. You did not keep your word.

Your letter pines on about all your experience with Dow Corning, while in the same breath talking about how you know how to do my job; yet you don't want my job, but have offered to be an "Influencer" from behind the scenes, i.e., you want a puppet master role and want me to accept your instructions to do whatever you want me to do... and again, while falsely accusing me of being a tyrant or CEO, etc; yet you propose that very thing for your role. Your proposal is the elitism we are all trying to get away from. Thirty years' experience with Dow Corning, an incorporated entity with powerful reach and deep pockets, is not something that in any way qualifies you to know and execute unincorporated land and soil jurisdiction assembling. In other words, you're the one viewing everything through a corporatist prism, and so that is the only view you see.

Here are the facts: The Michigan Assembly is an unincorporated entity on the Land and Soil jurisdiction, operating under American Common Law (referred to as Public Law) and the organic laws

of our country. TMA Roadmap you were given makes that very clear. To have a CEO we would need to be a sea jurisdiction entity with a charter from the STATE-OF-STATE, using Articles of Incorporation and Bylaws, shareholders, a Board of Directors elected by shareholders who in turn elect officers, such as a CEO. None of those elements are present. The only corporatism present here is your way of thinking and viewing things.

You state that you were not given any roles or responsibilities to help build the assembly, and yet you were offered several: Study Group Coordinator, Outreach, Marshal at Arms training, and Recording Secretary; all of which you turned down at one time or another, citing that you didn't feel it was for you or that you didn't want to do a background check. And even though you were told that everyone taking on a role in the assembly did so, you indicated that you were above such things and reiterated it here in your letter. In fact, you're still misrepresenting that I wanted you to get vetted by the Continental Marshals, which isn't required in TMA Roadmap, but just that we'd used their vetting page to access the link to the background check; but you don't listen when I inform you apparently.

Another false accusation from you is that somehow the Coordinator can have secret meetings with his "friends" and not let anyone else participate. Here are the facts: While we all have the freedom to make friends among other ASNs, no one who has a role in the assembly started that way. The fact is, they all earned their positions and trust by rejecting their indoctrination, re-educating themselves in land and soil matters, and earning trust by having honor and integrity and putting forth the effort to build assets the assembly can use to do the reconstruction. TMA Coordinator Call is a Coordinator jurisdiction call; yet we put it out in the GA meetings that anyone may attend if they request it ahead of time; however, that doesn't mean they'll play a speaking role if they are not a Co-Coordinator. Meetings by the Coordinator within his jurisdictional role cannot be "secret" meetings; only meetings or email chains subverting the Coordinator jurisdiction or the assembly itself would be defined as "secret meetings" and intolerable offenses according to TMA Roadmap Standards of Conduct. Instead, you advocate working behind the scenes for yourself and conducting your own secret meetings to propagate your will for the assembly, up to and including visiting my home, rather than discussing anything on open assembly or TMA committee calls. However, we have transparency here, so this response to your letter is indeed being shared with the GA members so everyone knows what's going on with their assembly and why.

You state that you haven't attended the Orientation classes, and you dropped off just about the time we started the Universal Self-Governance classes from John Butruccio, because you don't need them; meaning, they are beneath you, particularly the self-governance classes. Yet, you exhibit all the toxic behaviors from that class, meaning you did need that training; however, I think you would have closed your mind to it. So, let's cover it here: The toxic behaviors are complaining, criticizing, condemning, resentment, resistance, and revenge. And you literally have exhibited all those behaviors in your letter to me alone. In fact by the end of the letter, you'd fleshed out your behind the scenes politicking (a corporate behavior) warning me that you think you have a better relationship with Anna von Reitz than I do, followed by a threat: If I don't do what you want of me, particularly if I don't submit to you and ask you oh, so nicely, that you'll start trouble for me with Anna.

Apparently, you do not comprehend nor understand my role as Coordinator nor the nature of the unique Coordinator jurisdiction, which has been explained to you in the first 3 classes of Orientation training. Here it is in a nutshell from Anna's January 18th Coordinator training: The Coordinator jurisdiction is unique because it is a sovereign using volunteerism as First Mover on his/her sovereign state to be the cause of the assembly in the first place, using the Summoning Authority's role. And further, you have also been presented with full disclosure of the TMA Roadmap upfront and presented with an ASN

Agreement to help us build the assembly under the terms found in that Roadmap, which you supposedly evaluated at the time and applied your autograph and sovereign seal. Do you not know what that means? It means that you agreed to lay aside part of your sovereignty to help serve Michigan by building the assembly according to that Roadmap, which you did not do. Instead, you now have all kinds of condemnation of the TMA Roadmap after the fact, which frankly seems contrived and made-up all of a sudden, such as, you don't think there should even be Standards of Conduct based on God's Moral Law; and in the same breath as saying you believe I should repent for hurting ppl, all the while you choose to cause conflict from behind the scenes, berate terms of assembling that you agreed to, etc. (I have harmed no one.) When you agreed to it, are you telling me you did not know what you were doing? And yet telling me also that you're the smartest person in the assembly because you think you know what to do and how to do it with no training on the land and soil. These things do not mesh; they simply do not go together, are hypocritical, and do not make any sense at all. This leads me to ask: Where or from whom are you getting all these contrarian ideas? You know that I know that we've had recent infiltrators trying to start trouble, don't you? Do you not realize that I was asked by the Federation to write a Roadmap for TMA along with agreements in order to gain reinstatement as a member state of the Federation of States, which was subsequently approved by them and our reinstatement from Anna herself on a zoom call she asked for on January 25th, 2022?

In the end, you did in fact set your autograph and seal to a statement to withdraw your ASN Agreement with TMA; however, you seem to think you can "reserve the right to fully participate in The Michigan Assembly". I'm sorry, but this just is not true. Remember, as an ASN, you have a duty to uphold the Public Law and the organic laws. Your rights end where the rights of others begin. You also have a duty to honor, meaning keeping your word and not interfering with the word, rights, privacy, etc., of others. You cannot and do not have a claim to participate in building the assembly if you will not agree to the terms of the assembling phase, and that has been supported by about 30 other sovereigns as they seek to serve Michigan. Returning to the private is fine; there is no shame in that, but attempting to force yourself and your will on the lives, albeit public lives, of others is unacceptable and intolerable. You do not have that right. Therefore, I accept your resignation from the assembly via the withdrawal of your ASN Agreement. You do not have to stay, and you do not have to agree, but go live in freedom in the private and realize that your sovereignty applies to your conduct, your word, and your life alone. We aren't going to interfere with your life and expect you not to interfere with mine or with the collective ours.

Finally, a word about the purpose for being at peace and why it is not only wrong, but dangerous for ASNs to say they are at peace while behaving as if they are at war. Such behavior, which you and some others that also left or were expelled, stems from a lack of comprehension of the context within which we live, given the usurping of our government by our contractors, our employees. Essentially, we are living in a military occupation of the British Territorial sea jurisdiction (maritime/admiralty law) working for a Papal/MUNICIPAL air jurisdiction (masquerading as being God's Law). According to their United Nations corporation international law (which they supposedly follow and apply to us) in their publication "International Humanitarian Law", "the United Nations Charter strictly prohibits the acquisition of territory by force, and that territorial occupation is not sovereign; but who is protected in occupied territory? Everyone who is not a combatant is a protected civilian, except Nationals of whose authority you are under." So, two things become important: 1) To status correct from being considered a citizen of the corporation (whose authority you are under) to a National of the Land being occupied. This earns us the protection of that occupying force by international law/treaty. 2) To declare your state of peace, backed up by flying the peace flag and acting at peace in all things. If you show that you are not at peace, but indeed at war by warring with others, with other states, etc.; the occupying force may come in and put that down as insurrection. And this is not only for you to understand but all others in

TMA GA and even the other states of the Federation of States: This warring with others, forcing conflict, and claiming we need to tear down the assembly under the terms of the current Coordinator jurisdiction (which, again, was approved by the Federation in order to regain reinstatement as a member state of the Federation of States) in the name of "helping build the assembly" is reverse-think that could be interpreted as enemy combatancy, and therefore, has no place nor any tolerance whatsoever at TMA. If you don't agree to what we are doing here or how we are doing it, have honor to just leave and live in the private or build your own assembly. As it is right now, you have withdrawn and will be counted as an ASN living in the private. Once our assembly is stood up, perhaps you can come back and reapply to join it if you can let go of your hubris. Take the Self-governance class; identify the "trash" in your psyche and get rid of it if you can.

End of Notice.

Communication by Richard Worden to support he as infiltrator:

From Article 3374...

- 1. Attacked the Coordinator (or the Coordinator jurisdiction)
- 2. Attacked the foundational elements: The Assembling Process via TMA Roadmap.
- 3. Attack progress made so far via sniping commentary on TMA – General Assembly MM channel on misrepresenting what we are doing here; December 7th, 2023.
- 5. Attempt to Divide and Conquer.
- 6. Gossip and cast doubts.
- 7. Accuse others of what he's doing herself.
- 9. Private agendas.
- 11. Lead with ego.
- 12. Attempts to elect himself into several different offices; actually, just one: Coordinator's puppetmaster.
- 13. Create conflict; refuse to work cooperatively: Wants things his way, rather than making good on his agreements.

"We want to bring home as many Americans as we can, but we don't have to put up with foreign agendas, obstruction, or interference." And as such, we are implementing our disciplinary process in our Roadmap.

Violations of TMA Roadmap, Standard of Conduct...

- D.1) Adherence to Creator's Moral Law.
- D.2) There are to be no politics brought from the corporate sea jurisdiction onto the land jurisdiction.
- D.3) There are to be no internal factions, such as enforced personalities or internal relationships that take precedence one over another outside of the proper context of the assembly phase according to lines of responsibilities.

- D.5) Members of The Michigan Assembly are to maintain their honor, integrity (keep their word), civility, and trustworthiness by continually earning other Assembly member's trust and never betraying it. Personal attacks of any kind will not be tolerated. Lying will not be tolerated. Gossip will not be tolerated. Any discussions dealing with others about behaviors and events must be done with objectivity.
- D.6) Members will conduct themselves with objectivity of perspective and speech (lacking objectivity, facts and evidence).
- D.7) Intolerable behaviors:
 - Personal attacks (particularly on the Coordinator's jurisdiction).
 - Lying (by misrepresentation and not keeping her word).
 - Lack of transparency (doesn't want to discuss things openly on a GA call or in committee; rather, wants to work behind the scenes and even meet personally do discuss things behind the backs of others).
 - Controlling/withholding information.
 - Pushing politics or politicking/posturing with assembly members; seeking to do the same behind the scenes and with AVR herself and threatening the Coordinator with it.

Violations of TMA Affirmation of Purpose and Conduct:

- Para.1) "...nor act as an insurrectionist...", based on email chains, he is working with infiltrator and possible insurrectionist Nicholas Kiciak.
- Para.2) "...I will conduct myself with honor, respect, peace and love as I self-govern... I will leave my ego at the door,..." while attempting to inflict his will on others without jurisdiction.
- Para.4) I affirm that I understand the process of Assembling, the plan for reconstructing our lawful government, and my role as an assembly member, as well as the role of the Federation, The United States of America unincorporated, and the Coordinator as Federation representative implementing the assembling process.
- Para.5) I affirm that I am here to support the Assembly... I will not force my will on any member of the Assembly, nor on the Assembly as a Committee of the Whole. I will not gossip, spread rumors, tell lies, hold secret meetings, or engage in any activity to destroy the good work that has been diligently and lovingly accomplished....
- Para.6) I affirm that I will stay in my lane, and will continue to study to educate and inform myself, so that I am able to turn to others to educate and inform. I will refer to myself as an American on the Land & Soil Jurisdiction. I am either an American State National or American State Citizen.
- Para.7) I affirm that I am aware that The Michigan Assembly consists of willing and able volunteers.... [Richard Worden's unwillingness to do a job within TMA, not keeping his word in helping reconstruct under the terms of the TMA Roadmap, and yet being included with personal agendas with Nicholas Kiciak behind the scenes shows differently.]
- Para.9) I affirm that I will not lie to The Michigan Assembly or the Federation of States, nor misrepresent any information, people, or mission/goal of or to the same. [Misrepresentation is what he seemed to engage in within his physical letter to the Coordinator and on the MM channel referenced above.]

Richard Worden was given all this information before he signed agreement to it as an ASN and made his Affirmation. And now, in true U.S. Citizen fashion, he's dishonored himself by breaking his word and is in breach of contract; however, he has withdrawn his TMA ASN Agreement, and therefore, withdrawn from The Michigan Assembly as per TMA Roadmap.

UPDATE: As of January 30th, 2024, it has come to light that Richard Worden continues to network with Nicholas Kiciak and others to subvert and operate against The Michigan Assembly via email, and given his own words, he is likely working as an “influencer” behind the scenes to create fear, dissent, division, chaos, doubt, mistrust, and to spread lies about TMA and the Coordinator and other public officials of TMA. First it was an operation to try and obtain as much private ASN/GA member information as possible, and though we’re not sure of Richard’s role in that part, he is certainly in the loop to help Nicholas Kiciak; and now a psyop to try and divide and conquer he continues to spread disinformation and misrepresentation on social media, like Telegram, and via emails blasts.
